# The APPG for Ending Homelessness Enquiry Session, 'How to prevent survivors of domestic violence from becoming homeless?



Wednesday 26 April, 15:00-16:30 Committee Room 17

#### Introduction

The APPG for Ending Homelessness is hosting this inquiry session in order to determine what policies are needed to prevent survivors and those fleeing domestic violence from becoming homeless.

Housing and homelessness are key issues for survivors of domestic violence. In 2016, 90% of women in refuges were reported to have housing needs<sup>1</sup> and in 2015/16, 6,550 people became homeless because of a violent relationship breakdown<sup>2</sup>, accounting for 11% of all homeless acceptances. We know that 35% of female rough sleepers left their homes due to domestic violence<sup>3</sup> and the APPGEH believes this needs to addressed.

The APPGEH have found a distinct policy gap in this area which we aim to fill with robust solutions. The purpose of this session is for the APPG and others, to hear evidence from experts from within the sector and from survivors of domestic violence who have also experienced homelessness. From this discussion the APPG will write recommendations based on the evidence heard and these will form one third of our end of year report on 'prevention'.

#### Witnesses

#### Lou Crisfield, Housing Caseworker, Miles & Partners LLP

Lou has been practicing housing law, both formally and informally for just over 30 years. She worked for Mind in Tower Hamlets and then Tower Hamlets Law Centre before joining Miles & Partners. Whilst at the Law Centre she developed an interest and expertise in domestic violence work and was a member of the MC of the local refuge for nearly 10 years. Lou has written and presented training courses to community groups and lawyers throughout her career, and during her time at the Law Centre much of this training was focussed on domestic violence issues.

#### Polly Neate, Chief Executive, Women's Aid

Polly joined Women's Aid as Chief Executive in February 2013. Leading the organisation through a time of significant challenge and change, she is also a prominent commentator on violence against women, and on sexism and feminism more widely. Throughout Polly's career she has influenced government and campaigned for policy change and social justice. Her previous role was as Executive Director of External Relations and Communications at Action for Children. Her responsibilities included public policy, campaigns, research, communications, brand and fundraising. Polly is a journalist by profession and she has also been a member of many advisory and working groups for government and opposition.

### Tanya Pinnock, Survivor

Tanya experienced homelessness last year after she was stabbed outside her university on International Women's Day by her former partner. Tanya couldn't return to her social rented tenancy of safety reasons and so was placed in a hotel for 5 days whilst additional temporary accommodation was being sourced. Two properties were identified yet neither met safety standards and she resorted to sleeping on a friend's sofa for two weeks. Professionals highlighted that she would be at high risk is she returned to her property, however no alternative solutions were offered and she went back as she felt there were no other options. Tanya is now living in a new borough and is in the last year of her degree. She uses her experience to deliver workshops in secondary schools on domestic violence and healthy relationships.

#### Jonathan Joseph, Assessment Manager, London Borough of Hammersmith and Fulham

Jonathan has over 30 years' experience working in the social housing sector; covering homelessness, housing options, housing allocations, developing housing strategy; commissioning and managing research projects. Jonathan has worked in a senior managerial capacity within the areas of Housing Needs and Homelessness for the past 17 years. He believes in getting it right first time in terms of service delivery, ensuring that the customer is at the heart of the business planning process. Jonathan has worked at a variety of London councils; Hackney, Westminster, Southwark, Enfield and is currently located at Hammersmith & Fulham.
